

Purpose of the VPMA Certified WDI Inspector Program

Since termites and most other wood destroying insects are generally hidden from view, it takes a trained professional to carefully detect conducive conditions, to know the habits and patterns of each insect and to pinpoint signs of infestations. Sending a technician out to perform WDI Inspections without this training can lead to missed signs of infestations, inaccurate reports and big headaches for your company.

John Reid and Bryan Vaughan team together to present the VPMA Certified WDI Inspector Program. They will review pest identification biology and behavior (self study requirements are outlined below), define what a thorough inspection involves, lead technicians in discussions surrounding the nuances and gray areas of conducting WDI Inspections and provide step-by-step detail about completing the NPMA-33.

WDI Program Specs

- Each candidate for certification must be employed by a licensed pest management company and have a minimum state certification in category 60 (registered technician).
- Attendance does not ensure certification. Each participant must pass a 50 question multiple choice, true/false format exam administered at the end of the workshop, with at least a 75%.
- This is a voluntary certification and is NOT required by VDACS.
- Certification is good for two years.
- If participant does not pass the exam, he must retake the exam within 6 months at a regularly scheduled course and test date, or with an authorized proctor. Retest will be \$25

Pre-Requisites

- Each participant must be employed by a licensed pest management company.
- Each participant must have a minimum certification in category 60 (registered technician).
